Italian Hospitality School announces the call-1 for the participation in the competition in the Erasmus Adult Education Project KA1 2023 “Adult Education Mobility” with project No. 2023-1-IT02-KA120-ADU-000192791 for Individual learning mobility of adult learners during the period from September 02, 2024 by December 30, 2024.

The objectives of the Erasmus Adult Education Project and the Call-1 are:

1. Enhance digital competence (basic and advanced) and digitalization competence of adults for effective use of modern technologies in hospitality and improvement of professional skills. ( During the practical training in host institutions low-skilled adult learners and educators of ITALIAN HOSPITALITY SCHOOL, will have the possibility for the first time to learn how to use Hotel Management Software "OPERA PMS". Given that digital skills include more than the command of technology (for instance, changing social practices) teaching digital skills to people who grew up long before internet and social media can be challenging. In order to be successful, training provided have to appeal to the current lifeworld of low-skilled adult people while at the same time overcome mismatching lifeworld. Low-skilled adults’ intrinsic motivation to learn is particularly high if the interaction with new technology is closely related to their social space and everyday life (BMFSFJ 2020).Furthermore, digital technology promotes social inclusion, It is an important part of modern communication and of participation in the community and in society.)
2. Support low-skilled adult learners and IHS educators in developing foreign language. Learning and practicing a second language in a social setting creates great opportunities for fellowship. Sharing the same goal of learning a foreign language creates a base for all sorts of social activities, as well introducing low-skilled adults to a new culture. During the mobility low-

skilled adults working on their language skills together may watch popular soap operas in English or listen to an opera in German. Educators of ITALIAN HOSPITALITY SCHOOL will learn how to adapt their teaching style as well as adjust the environment and course materials to the particular needs of low-skilled as well as age-related barriers like longer reaction times, age-related health problems, cognitive and motivational hindrances. A common language and understanding, facilitating mutual learning. All mobility participants educators will improve teaching and presentation skills in English and overcome the barriers in communication with local community representatives.

3. Employment and career opportunities and EU origin, improve competences in Sustainable Development. By implementing the mobility activities for low-skilled adult learners, IHS can offer a high-quality training according to learners' level of education, and valuable experience of travelling to another EU country, thus providing them better understanding of Europe as a region with common political, economic and social principles and meaning of sustainable development in hospitality. Sustainable Development competences and their continuous improvement are necessary to develop without dependence on degree in the frame of life-long learning for improving competitiveness of these individuals in labour markets and social inclusion social of hospitality or other area professional or amateur, citizen interest in the form (period, form content) suitable for adults. Educators of IHS will develop Sustainable development competencies of Educators, improve knowledge on Sustainable Development Issues, improve intercultural competencies, practical guidance, and learn methodologies of of SDGC.

<p><u>Number of competition mobilities:</u> The competition includes 20 individual learning mobilities of adult learners, 8 short term mobilities ( upto 30 days) &amp; 8 long term mobilities (upto 60 days) each mobility. At least 6 of 16 participants selected will be participate with fewer opportunities.</p>

Mobility Schedule: Individual schedule for up to 30 days mobility of each participant will be arranged during the months from September 02, 2024 by December 30, 2024. The 2 (two) travel days will be included to the overall schedule.

The participant will develop skills and competences in:
